Secretary's Report (Pete Fantle reporting)

• Minutes of the October 20th meeting reviewed by email and were unanimously approved.

<u>Treasurer's Report</u> (Steve Fabry reporting)

Current Balances

\$3,004.90 Checking Book Balance @ 11/21/2021 \$11,817.56 Money Market Balance @ 10/31/2021

- \$3.500 transferred to checking on 10/7/21
- Estimate for end of the year is currently \$13,172.46
- New quarterly dues will be \$118.
- Boyer is transitioning treasuring duties to Lazarides.

Architectural Control Committee (ACC) Report (Larry Acker reporting)

Lot 38 is continuing on extensive remodeling.

Environmental Control Committee (ECC) Report (Nick Connor reporting)

- Meeting with the ECC has been scheduled for Dec 6th
- ECC is working on a erosion control at the shoreline near Lot 22
- They are investigating dead trees near Lot 55 to determine if they are on common property.
- Dog woods will be planted in the spring to revegetate the areas where invasives were removed.
- A \$1 raise and \$350 bonus was approved for our employee.
- The Board and ECC are discussing how useful the continued removal of Muskrats. This year 31 muskrat were removed from around the lake.
- The Lake Association Fish Farm license is currently addressed to a former ECC member. We are investigating changing the license to another location.

Old Business

- the Board is compiling a list of the preferred commication venue for homeowners. This includes updating existing emails. Also, the Board is discussing ways to handle communication for those folks who do not have email.
- The Manager position has been open for some time, we are currently evaluating and have tabled discussion for now.

New Business

- Lawn mowing contract has been renewed for 2yrs. We have budgeted for 21 mows per year. Current contract prices states:
 - o 2022 = \$674.00
 - o 2023 = \$693.00
- The special assessment billing should be sent out to homeowners soon.
- The Board discussed the creation of a formalized process for boat delivery and pick up. This will prevent any damage to common property.
